1. Conditions of Contract. Reserving a boat and filling out the rental contract, the customer accepts the terms and conditions set forth on the back of the rental contract of hire BLU and BLU. Please read the terms and conditions. In the event that something was found to be clear, something with which you disagree or incomplete information, please contact our staff or the office of BLU and BLU rental, which they will hire. It 's important that the terms and conditions of the contract are included in their entirety

2. Conclusion of contract Booking the boat desired, the customer accepts the conditions of the contract and agrees the rental price indicated during the booking process. The confirmation of the accession took place can be sent via e-mail, fax, or receipt issued to the customer. The latter is bound to leave an e-mail to make sure that the confirmation reaches the recipient.

3. Reservation: Changes / Cancellations **3.1** Any change to a reservation BLU and BLU hire is subject to approval and may be made only if the charter has not been billed. If the cost of the booking change is greater than the cost of the original, will be charged the difference. If the cost of the booking change is less than the original is not no refund **3.2** Any change to a reservation must be made by phone or sent in writing to info@blueblunoleggio.it **3.3** If the driver fails to collect the boat on the day and hour set, there will be no refund and the cost of rental will be charged. BLU and BLU rental is not obliged to reserve the boat after time and this boat can be used for another booking. **3.4** BLU and BLU charter will authorize any additional charges on that credit card when picking up the boat. If the amount of authorization for any reason, should not be granted the customer can not rent the boat.

4. Waiver Without additional cost the customer may cancel the booking in writing within two weeks from the date of booking. This can be done without having to give any kind of explanation on the reasons for the cancellation. This right, which is explained in the clause above is applicable when a cancellation is made in writing to the following address: info@blueblunoleggio.it within the stipulated period. The right of cancellation as described above does not apply if the booking is made less than two weeks from the date of withdrawal of the boat. There is no additional charge for the cancellation of the reservation only in cases where the customer is responsible for unusual and unpredictable events such as: - Natural disasters (floods, fires, etc.) - Wars - Terrorism If the cancellation is for reasons of health, they must be put in writing Once we receive confirmation of booking, the BLU and BLU charter is committed to ensuring the availability of the vessel for the period reserved.

5. Terms of payment **5.1** BLU and BLU will cash rental customer's credit card the amount of rent from the time the reservation is made, by issuing a receipt after returning the boat **5.2** All additional costs are subject to VAT and will be charged to your credit card at the end of the rental itself. **5.3** The choice of currency will be determined by BLU and BLU hire. **5.4** The customer will be responsible for all additional costs in case of wrong information and reservations cancelled. **5.5** The Company reserves the right to charge the customer additional unforeseen costs (mooring at other ports, fines ...) within two months after the end of the lease. The customer will be informed of the additional costs of hiring by sending an invoice by mail or email. **5.6** On return of a boat rental attendant BLUE and BLUE calculate any missing fuel. The fuel cost for the service is indicated on the Rental Agreement. **5.7** At the beginning of the rental BLU and BLU will hire as a security deposit authorization on your credit card. This authorization will be returned at end of hire provided that the boat is under the same conditions for the start charter. In the event that the boat has damage, dirty or missing fuel, the extra amount will be deducted from the authorization; if it were less will be asked for a new authorization on your credit card.

6. Payment authorization The customer authorizes the company to charge any extra on the credit card attached a copy of the contract

7. Privacy **7.1** The following personal information concerning the rental to the nominee can be processed, stored, transmitted and used by Landlord in computer systems: - Name, surname, e-mail, fax, telephone, cellular and date of birth of the rental, the information on driving licenses, the customer number, the amounts paid by the hirer to the lessor. From time to time we will make available personal data for commercial and administrative. We may also use this information to do research in archives of the credit bureaus, which will record these searches. This information will be used only to simplify decisions credit references, or, occasionally, to prevent fraud or to trace a debtor. **7.2** Personal information specified in paragraph 14.1 may be provided to the following individuals and companies: - Banks - Legal practices - Credit recovery companies - Shipyards - Transport companies and travel agencies cooperating with the landlord Under the Privacy Act, information may be disclosed only if it is required to protect the legitimate interests of the lessor, people and companies referred to in Section 14.2 or public institutions. This will happen for example if: - The information given for rental is incorrect - Chartered the boat is not yet home 24 hours after the end of the rental period, including any extensions - Payment due by the lessee, in the form of a check, or credit cards is not paid or is protested, or bills are not paid rent. - Chartered the boat is stolen or damaged.

8. Jurisdiction For any dispute arising from and / or in connection with the hire of the vessel, in particular any action necessary to recover from compulsive quality of credit accrued BLU and BLU rental is exclusive jurisdiction of Cagliari.
